- 2. Original valid **Philippine passport** and one (1) photocopy of its data page (Original to be returned to applicant after it is cancelled);
- **3.** Original and one (1) photocopy of **Einbürgerungszusicherung** (Original to be returned to applicant);
- 4. Self-addressed **envelope** with Euro 3,95 stamps (*Einschreiben*) [*Certification and Affidavit to be released via mail after five (5) working days*];
- 5. Fees: Notarial of Affidavit Euro 22,50 Certificate of Renunciation - Euro 22,50 (<u>CASH PAYMENT ONLY</u> for walk in applicants)

APPLYING VIA MAIL

For applicants who cannot appear in person at the Philippine Consulate General in Frankfurt, they may send the above-mentioned requirements by mail (except the fees) provided that the **Affidavit of Renunciation** is signed by a German Notar and authenticated by the State Judicial President (Landgericht) where the Notar is registered.
